Competitive Rules for Participation „Permanent Makeup Brows”

Category “Ombre”

29.09.2019 (Sunday)

Participation criteria

Participation in the competition Permanent Makeup Eyebrows is allowed to all specialists who are working with equipment method and/or hand method for permanent makeup and have a Certificate for permanent makeup and/or microblading, as well as professional experience of at least 1 (one) year. Every participant in competition Permanent Makeup Eyebrows must present diploma/certificate for the first completed course in the respective category. According to the date of the diploma, each participant will be allocated to one of the following Divisions:

- Division 1 (Junior) – professional experience up to 2 years
- Division 2 (Master) – professional experience over 2 years

To participate in the competition, it is mandatory to complete online registration on the Organizer’s website (www.arenaofbeauty.bg) and to pay participation fee by **26.08.2019**.

Participation fee for one category – 250 BGN

An application for participation for which no participation fee has been paid and a Certificate of Competence has not been sent is invalid.

Participation places are limited and applications will be processed according to the date of receipt. The participants will receive confirmation for participation in the Championship on the e-mail address provided in the registrations.

Task

The participant must complete an Ombre technique on eyebrows, with equipment or manually on a live model.

The competitor has 120 minutes (2 hours), including placing anesthesia to make the eyebrows of the model. Technique Ombre technique is performed with machine method and/ or microblading.

Requirements for performing the technique:

- The makeup must be done in a way that shows the gradation of the colour.
- Throughout the whole length of the eyebrow there must be applied colour. The gradation of the colour has to be soft and even.
- The pigment must be applied as pixel.
- The start of the eyebrow has to be airy, the transition to the body should be gradual.
- The eyebrows should have clear borders, but not brightly outline contours.
- The makeup should look natural.

TERMS AND CONDITIONS

Every competitor works with his/her own model. The model must not have decorative cosmetics and old permanent makeup in the zone that will undergo treatment. The competitor must abide all hygiene rules which are mandatory for this treatment. It is forbidden to enter the competition zone with clothing different than the one described in the Rules for participation. Competitors must carry everything stated in "ORGANIZATION OF THE WORKPLACE". Competitors can use products and equipment from any brand.

Before the start of the competition

The competitor must not touch the face of the model and start the preparatory makeup.

The competitor cannot use decorative cosmetics.

Before the start of the competition the competitor must take the model for initial photo session.

Work place set up - 15 minutes (not included in the competitive time of 120 minutes for the category). The time includes: packing the workplace, turning on the equipment, pigment preparation and consumables. The equipment must be connected to electrical network so that the competitor can ensure it is working. In case there is a problem, the organizers must be informed.

During the competition it is allowed to use of all kinds of local anaesthetic, at the discretion of the competitor; all kinds of products for making eyebrow permanent makeup in hair by hair technique; all kinds of tools for making eyebrow permanent makeup in hair by hair technique. All materials must be within their expiration dates and have certificate for quality, which has to be sent to the organizers 1 month before the competition.

During the competition it is forbidden to use decorative cosmetics and injection anaesthetic. Competitors and models are not allowed to speak loud during the competition. It is strictly forbidden for competitors to exchange any material during the competition! Assistance and consultation between the competitors are not allowed.

After the competition

Models must stay in the hall for the first jury assessment. If a model leaves the competition zone and does not wait for the evaluation to be completed, the competitor who worked with this model will be disqualified. Photographs of the models after the treatment will be taken immediately after the end of the competition.

Cleaning of the work place after the treatment – 10 minutes (not included in the scheduled time for the competition).

If necessary, the competitor must be ready to comment his/her work in front of the jury. The decisions of the jury are final and are not subject to review.

Important! During the competition, there is a competition area supervisor who can give 5 penalty points in the following cases:

1. The requirements for work sterility and hygiene are not met.
2. The competitive time has not been met.
3. The terms and conditions of the championship are been violated.

In the case of multiple or significant violations, the competitor can be disqualified.
