

## TERMS AND CONDITIONS FOR PARTICIPATION IN LOTTERY FOR BEAUTY SPECIALISTS, VISITORS OF FAIR ARENA of BEAUTY PROFESSIONAL 2018

Participation in the lottery starts on 05 October from 10:00 am and ends on October 07 at 13:20.</p> <p>3. Participation in the lottery can take any visitor to the International Fair Arena of Beauty Professional 2018, which is an adult capable person and holds a Professional Qualifications Certificate in the profession which he/she is engaged in and is associated with beauty industry (cosmetician, dermatologist, manicurist, pedicurist, hairdresser, make-up artist, kinesiotherapist, masseur and other specialists from the sector) and filled in completely and correctly the questionnaire. The questionnaires can be dropped in a specially prepared for this box placed in the lobby of Exhibition Halls 5 and 6 of Inter Expo and Congress Center, Sofia, 147, Tsarigradsko shose Blvd.</p> <p>4. The questionnaire is free and the prizes are for advertising purposes.</p> <p>5. Partial or illegibly completed questionnaires will not participate in the draw of ten vouchers.</p> <p>6. More than one questionnaire filled in by the same person leads to cancellation of his / her participation.</p> <p>7. Each voucher entitles the winning participant to choose a product/s and/or a service/s indicated on the voucher value, from only one company exhibiting in International Fair Arena of Beauty Professional 2018, which is a Bulgarian legal entity</p> <p>8. By receiving the voucher, the winning participant of this lottery, gives further and explicit written consent that the names and the photograph be made public and used on the Organizer's official site and Facebook page, and no payment is due by the Organizer of the lottery. Any other data that has become known to the organizer in connection with winning of the vouchers can not be disclosed.</p>
